The company will inform its customers, in writing, that the Products are subject to specific U.S. sanctions against Russia and the Products cannot be used in any way, directly or indirectly, to support the exploration or production for deepwater (depths of more than 500 feet), Arctic offshore, or shale projects that have the potential to produce oil or gas in the Russian Federation, or in maritime area claimed by the Russian Federation and extending from its territory, including, but not limited to, the Yuzhno-Kirinskoye Field, without obtaining licenses from the U.S. Department of Commerce, Bureau of Industry and Security ("BIS"), the U.S. Department of the Treasury, Office of Foreign Assets Control ("OFAC"), or, if applicable, both BIS and OFAC.

If the company knows or is unable to determine if the Products will be used in any way, directly or indirectly, to support the exploration or production of deepwater (greater than 500 fe et), Arctic offshore, or shale projects that have the pot ential to produce oil or gas in the Russian Federation, or in any maritime area claimed by the Russian Federation and extending from its territory, including, but not limited to, the Yuzhno-Kirinskoye Field, then it will not deliver the Products or allow the Products to be used until the company has obtained the required license(s) from BIS and OFAC or, if applicable, both BIS and OFAC, and has provided PMI with a complete copy of all valid licenses obtained from BIS and OFAC, and provided PMI, in writing, the date the Products were shipped to the customer or put to use by the customer.
